Motion passed unanimously.

- A. New Mexico School Boards Association (NMSBA) 2021 Leadership Development Program Awards Superintendent Archuleta announced the awards and recognition awards earned by Board President Romero, Board Vice President Armijo and Board Secretary Duran throughout the year from NMSBA. The awards are for board members that have participated in more than 20 hours of training during the 2020-2021 school year.
- B. Retiring Board Members Gabriel Lucero and Leroy Lujan Superintendent Archuleta recognized and thanked Board Member Lucero and Board Member Lujan for their years of dedication and service to the students and staff of Las Vegas City Schools. Board President Romero and Board Vice President Armijo also expressed their appreciation and acknowledged their commitment to the district.

ACCOLADES:

A. Robertson Football – San Miguel County Commissioners Martin Sena and Harold Garcia addressed the board with a proclamation from San Miguel County proclaiming December 15, 2021 Las Vegas

City Schools Day in the community. The proclamation was approved by the San Miguel County Commissioners during a recent meeting recognizing the RHS Football Team for winning the 3A State Football Championship title. Robertson High School (RHS) Football Assistant Coaches Lucas Sanchez, Robby Armijo and Joel Silva shared the team's achievements earned during the season. The RHS Football team won the 3A State Championship.

NEW BUSINESS:

A. Finance Committee – The finance committee met December 15, 2021 at 5:15 pm and reviewed the November 30, 2021 bank reconciliation reports for the General Fund and Student Activity Fund. No variances were noted between the bank and the general ledger balances. The Student Activity Fund Balance Report was reviewed and no variances were noted as of November 30, 2021. The committee also reviewed the Cash Report by fund, Revenues and Expenditures Budget versus Actual Report, Capital Outlay Report, list of donations, list of open purchase orders \$50,000 and above, Pledged Collateral letter and the Supplemental Pay Report. The committee also reviewed and recommended the approval of the Student Nutrition Food Bid for January 1, 2022 – July 31, 2022.

- B. Capital Outlay Superintendent Archuleta shared the status of projects throughout the district. She stated that the propanel on the gym and sealant on the exterior at Mike Mateo Sena Elementary. A meeting was scheduled for December 20 to discuss the calibration for the marquee signs at Memorial Middle School, Los Niños and Sierra Vista. Dirt and debris will be removed from Old Memorial Middle School for approximately \$6,783. Landscaping to include dirt fill, rocks and all weather turf will take place at Los Niños Elementary for approximately \$27,405. Landscaping to include tree removal, renovation of current flower boxes, rocks and all weather turf is approximately \$32,205. The project design portion for the Sierra Vista project is approximately \$396,750 (district match 47%) and \$447,398 (state match 53%). The HVAC system for Marr Gym is approximately \$1.4 million; prep work is to begin in mid-January due to shipping issues. NorthEastern Construction was awarded the School Based Health Clinic project for approximately \$446,641.46. District is awaiting the timeline with final completion expected in mid-January. An interested party inquired about leasing Legion Park building and property. Information was sent to legal counsel for review.
- C. Audit Committee Report Mari Hillis, Director of Finance, reported that the audit has yet to be reviewed.
- D. Superintendent's Report:
 - 1. Personnel Report Staff Superintendent Archuleta reported the hire of Eloisa Muniz; resignation of David Steve Martinez and Nancy Spotts.
 - 2. District Update Superintendent Archuleta shared that Secretary of Education Dr. Steinhaus encouraged individuals to get vaccinated; announced the test to stay for those that were not vaccinated and exposed to a positive COVID case. The Cardinal Christmas Craft Fair had 22 vendors register for the December 18th event; flyers were distributed throughout the community. RHS clubs and teams decorated homes for the elderly and community for the Cardinal Christmas event. 36 families will be receiving food baskets for Christmas. Superintendent Archuleta thanked Principal and Bilingual Director Christina Gonzales for her efforts in coordinating a professional development training for staff with New Mexico Highlands University in TESOL, Bilingual and Title II. Capturing Kids Hearts will provide training for staff to help promote positive environments.
